Slavery and Human Trafficking Policy

4. Compliance with Legislation

5. Key Actions and Responsibilities

Risk Assessments

Due Diligence

We conduct rigorous due diligence when engaging new suppliers or renewing existing relationships. This includes supplier audits, self-assessment questionnaires, and reviews of third-party reports to confirm adherence to anti-slavery laws and ethical practices.

Whistleblowing Mechanism

Grassform Plant Hire Limited has established a confidential whistleblowing mechanism that allows employees, suppliers, and other stakeholders to report any suspicions or incidents of slavery and human trafficking.

6. Monitoring and Reporting

To ensure the effectiveness of our efforts, we implement robust monitoring systems, including:

- Regular review and updates to policies and procedures.
- Routine audits and compliance checks of suppliers and operational practices.
